

AGREEMENT
on a Double Degree

South-West University (SWU) "Neofit Rilski", located at Bulgaria, Blagoevgrad 2700, Ivan Mihaylov str. 66, represented by **Prof. Borislav Yurukov**- Rector

And

Vietnam National University of Agriculture (VNUA), located at Address: Vietnam, Trau Quy - Gia Lam - Ha Noi, represented by **Prof. Dr.Nguyen Thi Lan**- President

conclude this agreement for joint training of students in the Bachelor program "Sustainable Tourism" and the Master program " Management of Ecotourism", as a result of which the successful graduates will receive a diploma from both universities for completion on their degree.

PREAMBULE

The foundation for the conclusion of this agreement is the realization of the project "Licence, Master professionnels en formation ouverte et à distance pour le développement du tourisme durable en Chine, au Vietnam et au Kirghizstan", in which both universities are involved. In support of sustainable development of the joint cooperation in education is the policy pursued between Republic of Bulgaria and the Republic of Vietnam, expressed by concluding agreements on mutual recognition and co-financing of higher education. The implement policies to ensure control and quality of training of students from the two universities ensure high European standards of training, which in turn will contribute to the successful and professional development of the graduates.

Article 1: Subject of the Agreement

1.1. This Agreement is concluded in order to carry out joint training of students following mutually created undergraduate and graduate programs that take into account the specifics of

11.4 This Agreement was signed in copies in English, each deemed authentic.

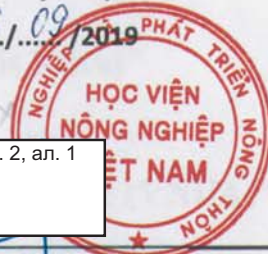
