

AGREEMENT

on a Double Degree

PROGRAM

between

South-West University "Neofit Rilski"

and

University of Economics, Hue University

South-West University (SWU) "Neofit Rilski", located at Bulgaria, Blagoevgrad 2700,
Ivan Mihaylov str. 66, represented by **Prof. Borislav Yurukov**- Rector

and

University of Economics, Hue University, located at 99, Ho Dac Di street, Hue city,
Vietnam, represented by **Assoc. Prof. Dr. Tran Van Hue** - Rector

conclude this agreement for joint training of students in the Bachelor program "**Tourism and Economics Management**" and the Master program "**Sustainable Tourism Management**", as a result of which the successful graduates will receive a diploma from both universities for completion on their degree.

PREAMBULE

The foundation for the conclusion of this agreement is the realization of the project "*Licence, Master professionnels en formation ouverte et à distance pour le développement du tourisme durable en Chine, au Vietnam et au Kirghizstan*", in which both universities are involved. In support of sustainable development of the joint cooperation in education is the policy pursued between Republic of Bulgaria and the Republic of Vietnam, expressed by concluding agreements on mutual recognition and co-financing of higher education. The implement policies to ensure control and quality of training of students from the two

Article 10: Duration of the Agreement

10.1. This Agreement will enter into force starting with the first academic year following the signature of this document by both Institutions.

10.2. The Agreement will last for a period of five years and will be automatically renewed for the same period after expiry date.

10.3. This Agreement may be terminated by either of the Parties, with a prior written notice, maintaining a 180-days-long termination period to be valid.

10.4. Upon termination, the whole documentation regarding the students and their course of study at the host Institution will be sent back to the Institution of origin.

Article 11: Resolution to a conflict and final provisions

11.1 The parties agree to solve in a friendly manner any controversy arising from the interpretation of the present agreement.

11.2 Changes to this Agreement shall be made in writing, under pain of nullity, and require signature of authorized representatives of both Institutions.

11.3 Parties undertake to amicably resolve disputes arising from the interpretation or implementation of this Agreement. Otherwise, the dispute will be settled by a court of competent jurisdiction over claimant's registered office and under the law of its country.

11.4 This Agreement was signed in 4 copies in English, each deemed authentic.
